# 3. Appointment of Vice-Chair

### 4. Minutes of the Meeting held on Wednesday 10 July 2024

### 5. Centre for Governance and Scrutiny (CfGS) Update

CfGS were not present at the meeting however it was noted that there were items already scheduled on the work programme and any further suggestions from members could be forwarded to Judy Trainer.

#### 6. Scrutiny Structures

The Scrutiny Structures table circulated was discussed. It was noted that the statutory guidance, which had recently been updated, referred to selection of Chairs and Culture but did not state how these should be sought.

- Updated scrutiny statutory guidance be circulated

### 7. Local Authority Updates/Best Practice

### • Supporting Young People into Employment Review

Cllr Stephen Lambert discussed the review that Newcastle CC had carried out regarding supporting young people into employment. The key points of the review included:

- There is a need for more level 1 courses
- There is a need for more part-time and work-based courses
- $\circ$  There is a need for intensive mentoring for NEETs and those at risk of NEET

A full discussion took place on the findings of the review and barriers for young people, including language, transport, types of course available, and individual support in further education. As part of the review, members conducted site visits of City Learning and spoke to young people.

The report was sent to Cabinet for their response, and this had recently been published.

The Scrutiny Work Programme table, which outlined the work of each authority was noted. This would be a standing item, with the network forwarding updates for inclusion.
